#### 1.0 INTRODUCTION

The County Fiscal Strategy Paper (CFSP) provides the broad strategic priorities and policy goals that guides the county government in preparing the budget estimates for the FY 2024/25 and over the medium term. The CFSP emphasizes the importance of engaging stakeholders and soliciting public input to ensure that the budgetary decisions align with the needs and aspirations of the county's diverse communities. The PFM Act 2012 Section 117, mandates the County Treasury to seek and take into account the views of the Commission on Revenue Allocation, the Public, any interested persons or groups and any other forum that is established by legislation.

As a result, the County Government organized for public participation forums in all the 6 sub counties scheduled on Monday 19<sup>th</sup> February 2024. The sub-counties include; Kaiti, Kibwezi East, Kibwezi West, Kilome, Makueni and Mbooni. Further, public participation forums were undertaken at the Mombasa and Nairobi Diaspora.

#### 3.0 EMERGING ISSUES FROM THE FORUMS

- Community proposals for interventions through public participation are often disregarded, leading to frustration among residents.
- There is a rise in vandalism of county projects with no effective measures taken to apprehend and prosecute the culprits.
- Administrative boundary issues persist between Kiima Kiu Kalanzoni ward and Machakos County, affecting residents whose IDs indicate Machakos County but do not receive corresponding benefits.
- Public land grabs are a growing concern and require urgent measures to secure.
- Kilome sub-county lacks flagship projects, highlighting a need for development initiatives in the area.
- The citizens were concerned about the court ruling on the revenue collection for Mtito Andei by Taita Taveta. It was however clarified that the County Attorney has taken up the matter and is working to challenge the ruling.
- Employment of locals in Thwake Dam Project and Konza Techno city.
- Exploitation of Gold mining at Syotuvali Kalawa ward
- The turn up for people with disability was low. There was urge for county government to organise transport logistics to increase their attendance
- Sign language experts in pp forums which will ensure accommodation of all groups
- Quarterly budget review meetings for the communities.
- Policy guidelines to prevent reallocation of funds meant for projects

#### 4.0 CHALLENGES

- Documents issued during the public participation were primarily written in English, resulting in comprehension challenges for many participants.
- Accessibility of data on all projects done in the county
- Incomplete/stalled projects within the sub county. Nguumo poultry slaughter house
- Lack of title deeds
- Holding public participation at sub county level limits participation of people
- Alteration of public views and opinions by county assembly and executive
- Time allocated for participation is not enough
- Untimely reimbursement of facilitation to participants
- Lack of a PA system during

#### **5.0 RECOMMENDATIONS**

- Provide translations of written information into languages that are understandable to community members.
- Enhance social security to reduce vandalism rate
- Top notch sand management and harvesting procedures

- Implementing stronger regulations and enforcement mechanisms to prevent illegal land grabs and protect the rights of marginalized groups
- Establish clear and consistent guidelines for defining and managing boundaries.
- Budget public participation process to begin at the cluster level
- Elections for development committees to be done in the next two months
- Linkage of CFSP key priority interventions with the budget proposals
- Market Committees to have sector representation and sensitize traders on the importance of revenue
- Promotion of green energy
- Undertake project appraisals and pre-costing before final budget allocation
- Provision of first aid kits during all sports activities
- Decentralize public participation forums to sub ward and ward level
- Include county assembly members in public participation forums
- Increase time for public participation
- Timely reimbursement of facilitation to participants
- Need for uniformity in allocation of sports funds, can be 2 million across all wards
- Provision of a PA system at the budget participation

## 6.0 SUMMARY OF COUNTY LEADERSHIP REMARKS ACROSS THE PARTICIPATION FORUMS

#### **6.1 Deputy Governor Remarks**

- a) **Sexual Gender Based Violence**(**SGBV**) -The Deputy Governor noted that the County Government is working in collaboration with police and judiciary to ensure justice will be served for all reported cases. She also stated that the county will enhance mentorship program for girls. The county is working in partnership with Police to curb GBV and in seeking justice
- b) **Mombasa Diaspora engagement -**The Deputy governor appreciated participation of Mombasa Diaspora cizens in county budgeting procwss
- c) Infrastructural development The Deputy governor noted that the national government is implementing the dualing of Mombasa Highway whose impact in the county would be instrumental. She also highlighted that the county is upgrading infrastructure in urban centres as centres of development. This would attract development partners funding such as the Kenya Urban Support Programme(KUSP)
- d) Athi river water pollution The DG Stated that the County Government in collaboration with Nairob Rivers Commission is addressing water pollution challenges in Athiriver. She reiterated the county is represented in the commission

#### **6.2** His Excellency the Governor's Remarks

a) **Inclusive Develop**ment: The Governor assured the participants on his administration commitment to equitable distribution of county resources. He also urged the diaspora groups to devise mechanisms of mobilizing citizens to ensure their participation in public forums.

- **b) Key priority interventions:** The Governor requested participants to consider the following priorities in the budget; water access, agriculture, health, roads and automation of government services.
- c) Water Access: The county is working on several water projects in Kibwezi East, including the Uyi dam in Masongaleni and the Athi-Tunguni Water project. Ensuring access to water is a key priority for the government, as outlined in the Governor's manifesto.
- d) **Taita Taveta/Makueni Conflict**: Makueni County citizens won't be required to pay taxes to the neighboring county, addressing a potential conflict issue.
- e) **human –wildlife conflict**-the county government constructed 76km fence and the national government would construct additional 60 km.
- f) **Ward Allocation**: The budget for 2023/24 allocates 43 million per ward across the county.
- g) **Grain Value Addition**: The government aims to activate the Makindu Grain Processing facility.
- h) Universal Health Access: The government plans to establish model health centers in each ward, ensuring 24-hour operation. Automation of health facilities will be implemented for efficient management. Diagnostic services for hypertension and diabetes will also be improved. The county was committed to addressing issues shortage of staff in health facilities.
- i) **Road improvement:** 23 roads have been selected by the national government for upgrading by KERRA. He reported that Syotuvali Bridge would be constructed by National Government.
- j) **Market Linkages**: Efforts will be made to address barriers created by middlemen in fruit value chains.
- k) **Quarterly Reporting on Project Implementation in Diaspora**: The county government pledges to involve diaspora citizens regularly in evaluating project progress.
- l) **ECDE Development**: 497 Early Childhood Development Education (ECDE) teachers' terms and the remaining cohort would be considered in the next FY 2024/25 budget
- **g) Bursary and scholarship programme** the county government was committed to improving retention of students in schools. the bursary committees comprised of representatives from the ward. He reported that 23 students under the county scholarship has scored grade As
- h) **Own Source Revenue (OSR)-**The Governor urged the citizens to pay taxes and levies accrued to the county so as to enable the Government to bridge the financing gap. On land rates, the governor encouraged citizens to pay land /plot rates to ensure adequate resourcing for development initiatives in towns and markets. The government had automated revenue administration and management to reduce leakages and enhance efficiency.
- i) New Administrative units- to improve access of public services to citizenry, new administrative units such as subcounties, locations and sublocations had been established in collaboration with the national government.
